EHH Monthly Update – August 2023

EHH 2022-2023

The 2022-2023 EHH grant cycle ends on September 30, 2023. Review any remaining balances and ensure there is a plan in place to fully expend all funds. Reallocate funding among subrecipients as needed.

As a reminder, ESG requires a 100% match. Make sure all match expenses are reported on the upcoming payment request forms.

EHH 2023-2024

Applications for the 2023-2024 EHH grant cycle are currently under review. Contracts will be executed in the coming weeks. The performance period will begin on October 1, 2023.

FMR Waiver

DEHCR's request for an FMR waiver received local approval from HUD Milwaukee and was sent to HUD Headquarters on 12/16/22 for final approval. In late May 2023, DEHCR received a request for clarification on a couple of items. DEHCR responded and is waiting for further information.

NSPIRE...coming soon

HUD published the National Standards of Physical Inspection of Real Estate (NSPIRE) rule on May 11, 2023 that made changes to the inspection standards for all units under public housing, housing choice voucher, multifamily, and Community Planning and Development (CPD) programs; this includes ESG programs. NSPIRE emphasizes the health and safety of residents. For Public Housing Authorities, this rule took effect on July 1, 2023; for other agencies, **NSPIRE will take effect on October 1, 2023**.
